TERMS AND CONDITIONS

SHIPPING

TERMS AND CONDITIONS OF SALE

CONTRACT: All orders agreed upon between the seller (Cedar Infrastructure LP) and the purchaser are based on the terms and conditions provided herein, unless the purchaser has a quotation that indicates special terms and conditions, the general terms and conditions will be superseded.

PRICE: Prices are only valid as per the terms stated on quotations. (2.1) the seller (Cedar Infrastructure LP) has the right to withdraw quotations if written acceptance has not been issued by the purchaser by the time stated on quotations. (2.2) All quotations are inclusive of HST and are subject to any increases due to cost of materials, inflation, sales tax, and/or freight. (2.3) All quotations include delivery to site on week days and during working hours unless otherwise stated on the quotation or agreed upon by the seller (Cedar Infrastructure LP) and purchaser. (2.4) Delivery charges may apply when the purchaser requests deliveries to be made when quantity subtotals equate to less than the predetermined amount agreed upon between the seller (Cedar Infrastructure LP) and the purchaser. (2.5) Acceptance of quotations does not obligate the seller (Cedar Infrastructure LP) to release any product until credit is approved or other means of payment has been agreed upon. (2.6) The seller (Cedar Infrastructure LP) reserves the right to charge the purchaser a standby fee for unreasonable delay in unloading or releasing company trucks beyond one hour.

PAYMENT: Standard payments terms are net thirty days (30) with approved credit only. The seller (Cedar Infrastructure LP) reserves the right to charge the purchaser a service charge of 1.5% per month (18% per year) to overdue accounts.

DELIVERY: Deliveries will be made to the delivery address specified by the purchaser at the time of order. (4.1) Delivery dates mentioned in any quotations are estimated times only and may vary at time of order. (4.2) The seller (Cedar Infrastructure LP) requires forty-eight (48) hours of notice from the purchaser to ensure adequate time to schedule trucks and deliveries. (4.3) The purchaser shall be responsible for ensuring the safe and satisfactory access to site in order for drivers to offload.

TITLE OF RISK: The purchaser shall inspect the products purchased at the time of delivery and claims must be made immediately to the seller (Cedar Infrastructure LP) if any products are defective or missing. (5.1) A signature from the purchaser's onsite representative on the packing slip provided by the seller (Cedar Infrastructure LP) is deemed acceptance of the delivered products.

LIABILITY: The seller (Cedar Infrastructure LP) shall not be liable for delay of delivery caused by failure of transportation, strikes, accidents or any other cause beyond the seller's (Cedar Infrastructure LP) control. (6.1) Special project specific products ordered by the purchaser are not subject to cancellation. (6.2) Any special project specific products not taken by the purchaser will be charged in full plus an additional 25% handling restocking fee will apply. (6.3) Any returned materials will be subject to inspection and if deemed in good condition, a 25% restocking fee will apply. Material deemed in bad condition will not be accepted as a return. (6.4) The purchaser assumes full liability for specifications of materials ordered. The purchaser is reminded to verify all quantities and specifications at time of order. The seller (Cedar Infrastructure LP) will not be held liable in this regard.

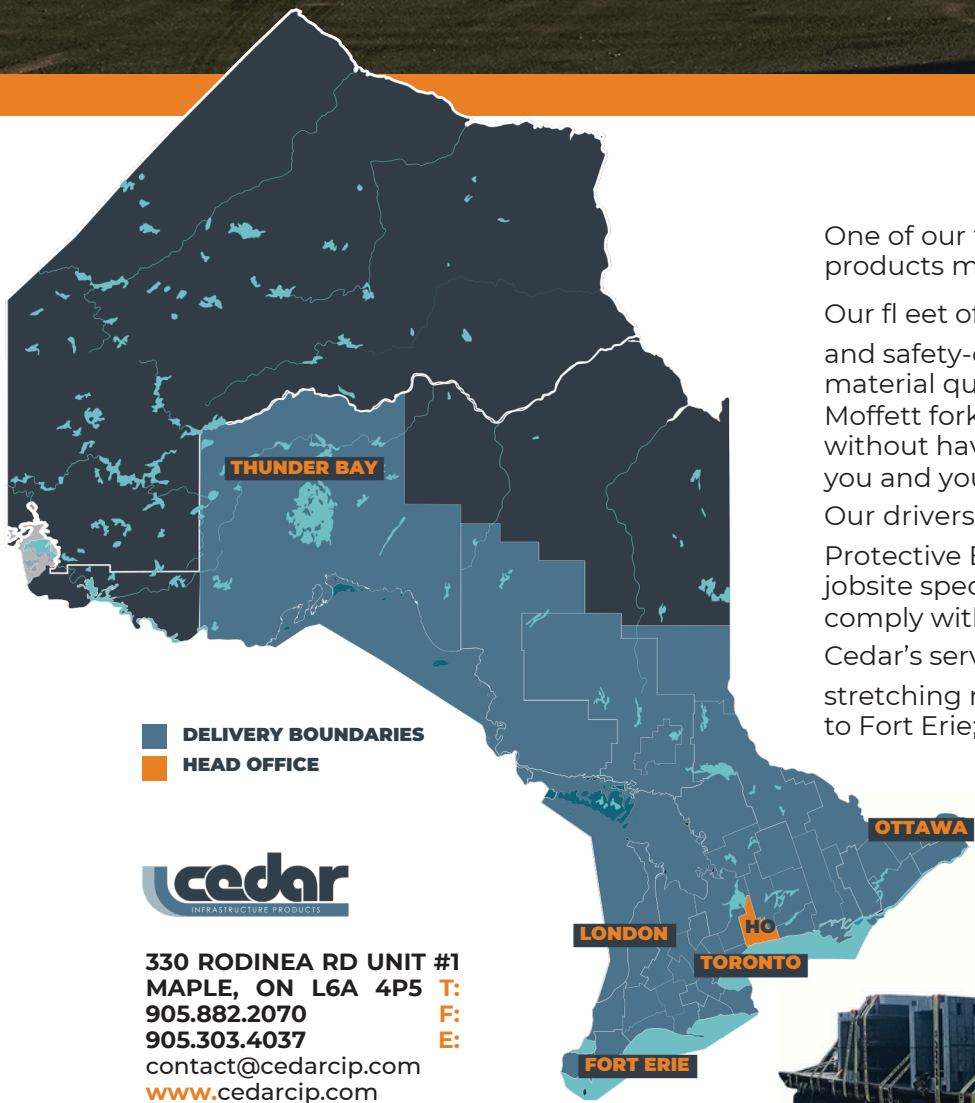
A NOTE ABOUT SHIPPING
